Announcement

The purpose of this notice is to advise that Ingenico US is announcing a withdrawal from marketing and sale of the PCI-PTS v3/4.x models of the iSC Touch 250.

Please note that all revisions within said part numbers are included in this notice. For example, ISC250-31P2592 includes ISC250-31P2592A, ISC250-31P2592B, etc.

The relevant dates and iSC250 support commitments are detailed below.

1_Rationale

Payment devices (hardware) and POS applications (software) are evolving technologies. They follow a natural product life cycle. Payment hardware is primarily governed by the Payment Card Industry Security Standards Council's (PCI SSC) regulatory compliance requirements, in addition to market activity and market demand.

Ingenico US is taking the action to EOL the products listed above due their replacement by products that have been significantly improved in performance, contactless reader certification requirement changes, and a desire to move to the PCI PTS V5 to provide products meeting the latest available security standard for the product range.

In this specific case, the main drivers for announcing this EOL of iSC250 series are:

- Available certifications for iSC250 are approaching their expiry dates and there will be a point where it will become difficult and extremely inefficient to maintain them
- iSC250 is PCI v3/4 and can't evolve (as all other Telium2 devices) to PCI v5
- The Lane/5000 and Lane/7000 are now available

 Any services after the March 31, 2023 date may be requested. Acceptance of said request with be based on the provided business case and parts availability. These services will be provided on a "best-efforts" basis based on existing stock or parts. No new parts will be procured after the EOS date.

3_Migration Options

Customers and business partners are encouraged to migrate to Ingenico's Lane/5000 or Lane/7000 Family of products, part of the Tetra platform.

- The Lane/5000 is recommended for customers needing an entry level solution requiring a signature/touch screen for enhanced customer interaction use cases and is a similar design to the iSC250 while taking up less counter top space.
- The Lane/7000 is recommended for customers needing a sleek design with a large screen for advertising and video while offering a premium consumer experience and engagement.
